- Sealed bids must be submitted to the office Kachankawal Rural Municipality, Jhapa by hand before 12:00
 Hrs on 2076/08/10 (26th November 2019) for NCB sealed quotation. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 2076/08/10 (26th November 2019) for NCB at the *office of Kachankawal Rural Municipality, Baniyani, Jhapa.* Bids must be valid for a period of 90 days for NCB after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
