The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 2079/12/07 (21th Mar 2023) for NCB at the office of Kachankawal Rural Municipality, Baniyani, Jhapa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amount mentioned above which shall be valid for 30 days beyond the validity period of the bid.
