
Re Invitation for Bid for the Construction of Drain and gravel at Baniyani – Pathamari Naya Bazar Road.

1. **Kachankawal Rural Municipality** has allocated funds towards the cost of Construction of Drain and gravel at Baniyani – Pathamari Naya Bazar Road. and intends to apply part of the funds to cover eligible payments under the Contract for below given Contract details. Bidding is open to all eligible Nepalese Bidders.
2. **Kachankawal Rural Municipality** invites sealed bids/Sealed quotation or electronic bids from eligible bidders for the given below construction activities under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding:-
 - a) **Registration certificate of a firm, organization or company**
 - b) **Business registration license**
 - c) **Value Added Tax registration certificate**
 - d) **Tax clearance certificate**
 - e) **A written declaration made by the bidder**
 - f) **Other documents considered necessary by the Public Entity**
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Kachankawal Rural Municipality, Kachankawal, Jhapa, Ph.No 9862679111, 9814092877.**
4. A complete set of Bidding Documents may be purchased from the office **Kachankawal Rural Municipality Baniyani, Jhapa** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **NRs 3000.00 for NCB** till 18th July 2018 (2075/04/02) for NCB till Office hours.
5. Pre-bid meeting shall be held at **Kachankawal Rural Municipality, Baniyani, Jhapa** at 10st July 2018 (2075/3/26) at 12:00 **Hrs.**
6. Sealed bids must be submitted to the **office Kachankawal Rural Municipality, Jhapa** by hand or courier before **12:00 Hrs** on 19st July 2018 (2075/04/03) for NCB sealed quotation. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 Hrs** on 19st July 2018 (2075/04/03) for NCB at the **office of Kachankawal Rural Municipality, Baniyani, Jhapa.** Bids must be valid for a period of 90 days for NCB after bid opening and must be accompanied by a bid security. Which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

9. In other words the prevailing law will be in accordance with the law.
