- 5. Sealed bids must be submitted to the *office Kachankawal Rural Municipality, Jhapa* by hand, courier or through PPMO web site before *12:00 Hrs* on 2076/10/02 (16th January 2020) for NCB sealed quotation. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 Hrs on 2076/10/02 (16th January 2020) for NCB at the office of Kachankawal Rural Municipality, Baniyani, Jhapa. Bids must be valid for a period of 90 days for NCB after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
- 7. Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
- 8. If the last date of purchasing and submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. Other related rules and regulation are as per Public Procurement Act, 2063, and Public Procurement Regulation, 2064.
